1. STUDENT PERSPECTIVES

The students described how they kept in touch during the pandemic and some of their performances this year, including the Orchesis Showcase, the Addison Trail Diversity Show and at the Spirit Assembly.

Members of the Board thanked the students for coming to share their enthusiasm about dance.

2. STUDENT BOARD MEMBER QUESTIONS AND COMMENTS

Jade Toledano, North High Student Board Member, updated the Board on happenings at North High in April and May, including the Spring Art Show; the spring play, "The Curious Incident of the Dog in the Night-Time:" Drug Awareness Week; Academic Awards; AP Testing; Mental Health Awareness Month; and Staff Appreciation Week.
