The Policy Committee of Community High School District 99 met on Tuesday, September 5, 2023 at the Administrative Service Center. The meeting was called to order at 6:17 p.m.

 Administration recommended adding, at the conclusion of the first paragraph: "The
 Superintendent is authorized to appoint employees pending Board approval at the
 next Board Business Meeting." The consensus of the Policy Committee was to accept
 the Administration's recommendation.
 - o 5.90, Abused and Neglected Child Reporting
 - 5.125, Personal Technology and Social Media; Usage and Conduct In addition to the PRESS revisions, the Administration recommended removing the last line of the Social Media section that provides examples of social media. The consensus of the Policy Committee was to accept the Administration's recommendation.
 - o 5.150, Personnel Records
 - o 5.230, Maintaining Student Discipline
 - 5.260, Student Teachers
 - o 6.135, Accelerated Placement Program
 - 6.230, Library Media Program Dr. Thiele explained that students and parents use the Curriculum Objection process when they have concerns about curriculum materials and members of the community use the Uniform Grievance Procedure.
 - o 7.275, Orders to Forgo Life-Sustaining Treatment
 - 7.305, Student Athlete Concussions and Head Injuries

 - 8.20, Community Use of School Facilities Dr. Thiele explained that Dr. McGuire,
 Assistant Superintendent for Learning Resources, is currently reviewing facility usage
 and the associated costs. He stated the Administration recommends the Board waits
 to review this policy, and the accompanying Administrative Regulations 8.20 AR1 and
 8.20 AR2), until Dr. McGuire has completed his assessment. The Policy Committee
 agreed with the Administration's recommendation.

President Renner inquired about the enforcement of the new cell phone policy, that was put in place at the start of the school year. Dr. Thiele stated he recently met with representatives of the DGEA and there were no concerns expressed.
