The minutes of the October 15, 2018 meeting were reviewed and approved.

- II. The following policies had revisions recommended by PRESS in its Update Memo. Revisions were in response to legislation, new public acts, and feedback. The policies will be brought forward for First Reading in January 2019. The Committee endorsed accepting the changes recommended by PRESS, with the noted modifications, to the following policies:
 - 5.220 Substitute Teachers

In addition to accepting the PRESS changes, the Committee endorsed, at administration's recommendation, changing the name of the policy to *Guest*

- Teachers, and substituting guest for substitute in the policy, as appropriate. Mr. Theis explained the rationale for the change from substitute to guest, noting it sends the message that the job is both valued and respected.
- 7.100 Health Eye and Dental Examinations; Immunizations; and Exclusion of Students
 The Committee recommended removing, under <u>Dental Examination</u>, references to kindergarten, second and sixth grades.
- III. Review List of District 99 Policies where PRESS does not have a corresponding policy.

The Committee agreed to review these policies every two years, with the following exceptions:

- Individual job description policies. The will be reviewed when there is a change in staff or responsibilities.
- Policies 6.236 Websites and Social Media and 7.326 Parent and Community Fund Raising will be reviewed annually.

The Committee agreed to review the policies, where administration recommends changes, when the next group of recommended changes from PRESS is reviewed, or by April 1, 2019, whichever comes first. Going forward, the Committee will review these policies at the first Policy Committee meeting at the start of odd numbered school years.
