Twenty-six (26) are expected to be for deliveries to the North Campus and thirty-nine (39) are expected to be for deliveries to the South Campus. These counts may vary slightly.

Each Purchase Order will indicate school delivery address, teacher name and classroom number. Shipments are to be delivered in separate packaging based on each Purchase Order. Individual Purchase Order materials may not be combined with materials from another Purchase Order even if it is being shipped to the same high school and same teacher as classroom locations may be different.

School address, teacher name and classroom number must be clearly visible on each address label, on every box, and must be able to be seen by our receiving clerks without their having to open each box.
